# **Board Briefs**

### March 9, 2021

Motion to approve February 9 Board Meeting Minutes: Bev Webb made a motion to approve. Les Vrabel seconded.

**Motion:** Carlos Tricoche made a motion to approve the survey that will go to the QLCA membership to determine what they would like to do about the tennis courts. Get an estimate to tear down or re-surface. Kate Helwig seconded. Motion passed.

**Motion:** Kate Helwig made a motion to contract with Dalexo Enterprises for \$14,675 to install a vessel sanitary system at the marina. Based on the "Clean Vessel Act" which provides federal funds to reimburse QLCA for 75% of the cost of labor and materials for the new system the net expense to the Association should be \$3,669 [budget is \$5,184]. Leah Duckworth seconded. Motion passed.

**Motion:** Kate Helwig made a motion to form a 9-member special committee chaired by Jack Dooley (of the Marina Committee) and comprised of 3 members appointed by the Directors of the Clubhouse, Pool and Marina Committees, for the purpose of recommending to the Board on or before their June 7, 2021 meeting, the best course of action for QLCA to take to come into compliance with the sanitary requirements for marina's as dictated by the Virginia Department of Health. All QLCA members in good standing should be made aware of the issue facing the Association and given an opportunity to submit comments/provide input to the Special Committee prior to a recommendation being offered to the Board. The Special Committee shall be disbanded after its final report is submitted to the Board." Les Vrabel seconded. Motion passed.

**Motion:** John Walters made a motion to contract with All Good Supply Corp for the sum of \$9,716.55 to create a custom cover for the Family pool. One other quote was received by Anchor Pools for over 10K. Rebecca Cho seconded. Motion passed.

**Motion:** John Walters made a motion to contract with Anchor Pools for the sum of \$13,148.26 to replace all 11 lights in the family pool. We have been unable to secure any other quotes for installs. David Dafashy seconded. Motion passed.

#### April 13, 2021

Motion to approve March 9 Board Meeting Minutes: Jim McCormack made a motion to approve. Leah Duckworth se-conded. Motion passed.

**Motion :** Leah Duckworth made a motion to waive the two estimates required for contractors and accept a single bid for the pond review and approve the request for the expenditure of \$2,800 to Jonathan Blair Wilson, Engineer. Mr. Wilson will do a visual inspection of Princess Pond and a summary report of that inspection. Funds will come from General Reserves. Kate Helwig seconded. Motion passed.

**Motion :** Carlos Tricoche made a motion to approve the Tennis Survey to go out to members concerning the future of the tennis courts. Kate Helwig seconded. Motion passed.

## **Coast Guard Auxiliary BOATER SAFETY COURSE**

**NEW VESSEL PUMP OUT OPERATIONAL:** A new pump out has been installed with assistance from a Virginia Department of Health (VDH) grant; total cost \$15,927.44. The VDH grant reimburses 75% or, \$11,945.58 for a total outlay of just \$3,981.86. The system is connected to York County's sanitary line via a grinder pump. Annual winterization and maintenance are required. These expenses are also reimbursable at 75%. Thanks to Jack, Craig and Chris K for bringing this project to completion.

**<u>RESTROOM COMPLIANCE WITH VDH:</u>** A "Special Committee" of Marina, Pool, and Clubhouse representative has meet twice to vet options for QLCA to come into compliance with the State laws regarding bathhouses for marina facilities. A report is expected at the June QLCA Board meeting.

**MAINTENANCE:** So far this spring, the office and shed have been cleaned, signs hung, picnic table refurbished, and the sailing prams repaired (and sailed). Water valves have been raised at A-Dock and water added for all slips. We also have new plants in the flower pots. Tasks are ongoing and Committee members Jack, Craig, Sam, Chris K., Van, Robert, Mike, Carlos, Bryan, Chris H & son Daniel are quick to respond to ongoing requests. Thanks team!

**ELECTRICAL:** The long anticipated upgrades are underway! Price Electrical has completed installation to slips A 1-9. We are awaiting delivery of a panel box, breakers, and marine pedestals to start on slips B1-11. All slips slated for new service are rented. Once the new service is fully in place, volunteers plan to remove the old service to decommissioned slips. The Marina Committee will evaluate annually the demand for power at additional slips.

**FUEL:** Our new pump and reel look good and work great! As of press date, fuel is \$2.89 per gallon for treated ValvTect gasoline. The Marina uses "Square" to process credit sales on site. Appointment only - 24-hour notice is requested. Text or call Dockmaster Chris Kolloff @ 757-642-7019.

**SLIP RENTALS:** As of April 30th, 51 of 63 slips rented (81% occupancy). Of the 51 renters, 31 are QLCA members, 20 are Limited Members (non-resident). Annual slip fees range from \$150 to \$2,400 and are prorated for new renters! Slips can now be paid by cash, check, credit or ACH bank draft. A list of available slips, with rates, is posted at the marina gazebo and on the website. Email Dockmaster Chris to find the right slip for your boat! cbkolloff@gmail.com RAMP RENTALS: Annual ramp rentals are April 1-March 31. Fee for QLCA members is \$100; a completed application with proof of insurance, required.

<u>SELF-PROPELLED ACCESS</u>: All QLCA members (in good standing) can enjoy FREE use of the Marina for "self-propelled" watercraft such as canoes, kayaks and stand-up paddle boards/SUPs. A completed application is required. The Marina committee will then issue applicants a parking pass and sticker(s) to place on your vessel. Applications are available on-line and at the gazebo.

**WEBSITE:** The Marina page on QLCA's website has up-to-date information including forms, rules and FAQ'S. The website allows slip and ramp renters to pay their bills and update contracts via a "password protected" portal. A special thanks to Jack for working on the site and Treasurer Lana Olson for her patience as we learn the new payment system. 

## **Princess Pond Project:**

- 1. Upon receiving approval of the motion (Motion: The Director of the Community Affairs Committee requests that the Board of Directors approve the expenditure of \$2800 to Jonathan Blair Wilson for a visual inspection of Princess Pond and a summary report of that inspection.), Leah Duckworth signed the contract for the inspection and sent it to Mr. Wilson who responded by suggesting several dates for the inspection. The May 4th date was selected and the meeting was set for 9:30 at the Pond.
- 2. Notice of the proposed meeting was sent to all the members of the Board of Directors as well as to Lana Olson, Cherrie Begley, and Bob Evans.
- 3. A small group met with Engineer Blair Wilson on the morning of May 4 at Princess Pond at which time a general discussion of the parameters of the evaluation of the pond and weir took place. Those from Queens Lake who were able to attend were Lana Olson, James McCormack. Leah Duckworth.
- 4. Mr. Wilson took the opportunity of our brief introductory conversation to say that he believes from his initial and cursory observation that the dam appears to be maintaining a balance between the two water levels of Princess Pond and Queens Lake. I took away from the meeting a positive feeling that he will identify remedial actions to preserve the integrity of the Princess Pond earthen dam.
- 5. Mr. Wilson stated that, as his firm is very busy, it will be about a month before he finishes and forwards his report to Queens Lake

- 1. Annual boat check has begun at all three lake access points. Six (6) boats unidentified and/or bearing outof-date stickers will be removed from the access points after April 30, 2021.
- 2. Per Mark Kilgore, DCR Regional Engineer: "The next step would be a meeting between our Dam Safety Director Wendy, the HOA officers and ourselves so that she could share the management perspective. We need to resolve the DBIZ before we can accept the EPP (which is generally needed for construction regardless of special low or low) and then process and issue the alternation permit." The Lake Committee requests permission to include legal counsel with the QLCA delegation for this meeting with the Dam Safety Director.
- 3. The concrete spillway has developed new leaks in the concrete weir next to the east bridge abutment. Attempts to locate the source of the water flow have not been successful. The water flow needs to be stopped before a concrete repair can be made. The situation appears to be similar to the leaks in 1989 when VDOT closed Queens Drive over the bridge. Hank Gerhart did a visual inspection and believes a professional geotechnical service is needed. We are attempting to contact geotechnical services for an exploration study to determine the source of the water flow.
- 4. Date for Richmond Primoid, Inc. work has not been be scheduled yet. The new leaks in the weir conflicts with their work.
- 5. QLCA sign at 161 West Queens Drive Lake Access was damaged. A replacement sign has been ordered and reimbursement from the vehicle owner involved has been received.


We had a somewhat active month continuing to assist Recreation and Beautification clean up the over grown vegetation on the backside of the tennis court. We continued the efforts of the Beautification Committee's starting the clean up the over grown weeds, etc and piled them near the area behind the back stop for the ball field. There is discussion to use volunteer labor to move the cut material to the roadside so it can be picked up by the County program or hire a company to chip and cut to smaller size the dead trees that have fallen near the piled vegetation.

We have received one quote and are looking for a second to chip and haul away. We have attempted to secure the backstop fence with zip straps and hopefully it should make the area safer. We may even repaint the fence too. Our thanks goes out to all that helped with their hands and equipment on the clean up.



#### SURVEY PURPOSE

Queens Lake Community Association (QLCA) members need to make some critical decisions about our four (4) tennis courts and we are asking for your input.

#### BACKGROUND

The QLCA Recreation Committee oversees the use and maintenance of the QLCA tennis court complex. Currently, 3 courts are used for tennis/pickle ball. One court, known generally as the "Christmas Tree Sale Lot" has a tennis back board and basketball hoop.

QLCA tennis membership has steadily increased over the past two years. The current membership count is 51. Two years ago we only had 19 members.

We received positive responses from our "Save the Tennis Courts Campaign" but the funds raised were not sufficient for our longterm needs. Donations are still trickling in and we thank everyone for their generous contributions. These donations are being used for temporary repairs.

Our courts are over 40 years old. The Committee estimates they have 1-2 years before becoming a safety hazard. At that point the courts become unusable. QLCA has historically supported previous major renovations to the courts. The Association now needs to develop a long-term financial strategy going forward.


