#### President's Message

This is the season to be grateful for our neighborhood pool. The perfect remedy during this heatwave. We have some other remedies coming up that require your attention, starting with the dam.

Members approved an agreement with York County last year to integrate repairs to the concrete spillway and earthen dam with the current County Capital Improvement Plan (CIP) for stormwater ravines. As part of the agreement, QLCA is obligated to convey a dam easement for necessary construction and ongoing maintenance at no additional cost to the County. Per Article VII of our bylaws, shareholders must approve any disposition of property (similar to the sewer/pedestrian bridge easement).

Also in the works is renovating our racquet courts. The Recreation Committee has obtained estimates to renovate both lower tennis courts and convert the upper court to multiple pickleball courts. Our courts are in poor condition and at the end of their useful life and additional capital funds to facilitate these improvements will also require shareholder approval.

A strategic planning presentation was given on June 15th, led by our Finance Director Tom Cho, and Treasurer Dick Quirin, to ensure sufficient capital reserves to address all our facility needs, including courts, clubhouse, pool, marina and lake within a long-term plan. This effort will be highlighted at our annual meeting in November.

Our facilities are foremost a benefit for QLCA members and guests. But they are also a selling feature, a quality-of-life amenity, and a long-term investment in our neighborhood. Your vote is needed to ensure we keep Queens Lake among the best places to live, retire or raise a family. A ballot initiative will be mailed to shareholders for a special meeting, Tuesday, August 13, 7:30pm at the clubhouse. (A copy of the ballot can be found inside.) Your vote, either in person, by proxy or delivered in advance to the office, is vital. If you're escaping the heatwave or leaving for vacation, don't forget to sign and drop off your ballot before you leave!

**Nominating Committee.** At least two (2) months prior to the Annual Meeting, the Board of Directors shall appoint a Nominating Committee composed of at least three (3) Shareholders in Good Standing, none of whom shall be members of the Board. No Shareholder shall serve for more than two consecutive years on the Nominating Committee. The Committee shall nominate persons who are Members in Good Standing to serve as Directors in a number at least sufficient to fill the vacancies on the Board.

Members may also nominate members to run by submitting a written nomination signed by three Shareholders, including a bio on the part of the nominee expressing willingness to run, and be received in the office by October 1, to be included on the ballot.


### Marina



During a recent work party at the marina we had over a dozen folks come out and help replace worn out decking and trim back the bushes surrounding the parking lot. Cyphers Plumbing fixed and/or replaced two of our three hose bibs.

Upcoming activities: Having Price Electric out to fix a couple of Pedestals that aren't working properly, volunteers putting new cedar shingles on the gazebo, and Labor Day Party in September.

Come out and enjoy the marina. Walk the docks, try your luck at fishing, launch a kayak or two, or just chat with the boaters.

### **Mid-Summer 2024 Pool Report**

#### **Membership**

Swim Team is precisely on target @119 paid swimmers Pool has already passed our membership target @215 as of mid-July

#### **Operations**

Our primary work force is neighborhood 15-17yr olds. We feel there is a benefit in having local & responsible kids from the neighborhood (often as their first job). We have employed Cindy and Micaela Timberlake as supervisors this year, and they are overseen by the committee. Cindy is also teaching group lessons this year, which have been very well received by members.

Another Year of Zero downtime!

Chemical management, mechanical maintenance, supplies, lifeguard hiring/management, communication to members.... It all takes a lot of volunteer time.

#### **Big Project Status:**

#### **Adult Pool**

The 2023 resurfacing has held up well. This pool continues to be 'easy' to manage since it has lower usage and less sun load. We only use about ¼ of our power and chemical budget on this asset.

The decking concrete sinking/cracking needs to be addressed soon. Proposals are being gathered.

#### **Family Pool**

The very large water leak from 2023 was properly repaired in the off season, so chem and water management has been easier this year

Tile/Coping/Resurfacing will be needed in the next 3-5 years (normal and planned)

#### **Bathhouse**

Siding/Soffits/Flashing/Drip Edges are all in terrible shape and need to be replaced soon (Target prior to 2025 Season)

#### Entranceway/fence/upper area

This area needs to be revamped. We are searching for a Landscape Architect help us with a new vision. Can anyone in the community help?

#### **Mechanical Stuff**

Everything is working.... And also everything is in a constant process of decaying

VFD drives installed in the past couple years have saved us from at least 4 single-phasing events that regularly kill pump motors.


#### Costs of Volunteerism / Cost

We have a core group of volunteers that carry a heavy load.

If we want to continue enjoying a high-functioning facility without burning out this handful of volunteers, we will need to increase external services from professionals in the coming years.

At a minimum in 2025, we will need to hire a CPO for operations management, and find clever ways to manage other topics.

# Lake

The Lake Committee reviewed proposals for lake management services and annual contract to monitor, inspect the lake and pond. The committee awarded an annual contract in July to Edgewater Services which conducted the first test earlier this month. A lab report is pending. York County Public Works staff and consultants presented stormwater plans, including individual property easements required, July 1 at the clubhouse. County Stormwater Chief, Joe Brogan and engineers answered property owner questions regarding easements and ravine stabilization.

The Committee is working with York Co District 1 Supervisor Doug Holroyd, to coordinate a formal request to Congressman Rob Wittman for federal funding assistance as part of the \$120M Colonial Parkway Rehabilitation Project. AH Engineering conducted a survey which was forwarded to the Congressman's office in support of this request which illustrates parkway stormwater runoff to the Lake. Mr. Holroyd is expected to introduce a resolution in August to support QLCA's initial request for assistance in collaboration with the County and State. Senator Danny Diggs and Delegate Chad Green have also spoken in support of our efforts. Congressman Wittman has been invited to address the community.



The Lake Committee conducted a watercraft inspection for 2024 Boat decals on June 3rd at all three access locations. Approximately forty personal watercrafts were delinquent; members with identifiable boat numbers will be notified. Boats in violation or abandoned will be auctioned after thirty days after notification. (Virginia law defines "abandoned watercraft" as a watercraft that is left unattended on private property for more than ten (10) days without the consent of the property's owner, regardless of whether it was brought onto the private property with the consent of the owner or person in control of the private property (§ 29.1-733.2). 2024 Boat decals are available at the office. Members can register canoe or kayaks on the website at https://queenslake.net/\_documents/lake//Boat\_Registration\_Form.pdf and decals can be picked up at the office on Monday, Wednesday and Friday 12-3pm.




In response to neighbor complaints, "no parking" signs were installed by VDOT at both ends of the dam road to discourage cars parking on the shoulder. The Committee is also reviewing policies to discourage trespassing on the bridge.

Your vote, either in person at the meeting, by proxy, or delivered in advance to the office is vital. The response by a quorum of members is required for these votes to be decided and binding. Thank you for your consideration of this important matter.

## **QLCA Special Shareholder Meeting/Ballot**

A special shareholder meeting will be held at the Queens Lake Clubhouse (234 E. Queens Drive, Williamsburg) on **AUGUST 13TH, 2024 at 7:30PM**. The purpose of this meeting is to conduct the QLCA business listed below in accordance with our corporate bylaws. A quorum of 33.3 % of current shareholders in good standing (137) is required, either in person or by written proxy (below). More detailed information is available online and will be presented during the special shareholder meeting. QLCA board directors will be open to answering your questions.

#### 1. APPROVAL OF DAM EASEMENTS FOR STORMWATER PROJECT

Purpose: Approve a permanent easement on each side of the dam road (Rte 716) to York County for construction and maintenance of the earthen dam and concrete spillway.

Details:

Allowance of common easement for construction and maintenance is consistent with the 2023 Agreement executed with York County, as part of the Queens Lake Basin Stormwater Capital Improvement Project (CIP), which includes \$1.7M County funds, \$1M State, \$110,000 QLCA one-time payment, and \$20,000 yearly payments by QLCA to the county for maintenance for 20 years.

Our Memorandum of Agreement voted upon and approved in 2023 states, "Subject to QLCA membership approval, QLCA will convey, at no cost to the County, all easements upon property own or controlled by QLCA that are reasonably necessary for the County's obligations under this agreement, including, but not limited to, for construction and maintenance of the lake, spillway and dam system (the "Easements")." The permanent easements needed for the dam and spillway construction/maintenance have been identified by the County and can be found in Attachment 1.

#### 2. REHABILITATION OF RACQUET COURTS

Purpose: To approve additional funds to restore (2) existing tennis courts and convert upper tennis court to (4) pickleball courts. The courts are in poor condition as a result of delamination and surface cracking and past their useful life. See Attachment 2 for visuals of current court condition.

Finances: The Recreation Committee solicited quotes to repave two tennis courts [#2, 3] and convert the upper tennis court [#1] to four pickleball courts. The bid of \$78,000 for all three courts realizes a \$10,000 savings from doing separately. NOTE: The 2023 QLCA member survey results, highlighted pickleball as first for household recreational activity most likely to do.

37,000 (current approved funds from capital reserve) 78,000 (estimate for restoration of courts 1, 2, 3) <a href="37,000">-37,000</a> (current approved funds) 41,000 (needed funds for restoration)

#### Scope of Work:

- Court #1/single upper court place new asphalt overlay; place acrylic resurface, place color concentrate, paint line, install pickle ball post, net and anchor (4 playing courts)
- Court #2 & #3/double middle court Fill cracks (2,000 LF+), place acrylic resurface, place color concentrate, paint lines, install tennis post, net and anchor (2 playing courts).




# Volunteer Spotlight: Suzanne Maggio of the Membership Committee.





# **General Recreation**

The Recreation Committee thanks all the attendees at the special meeting held this June for a discussion on the Tennis Courts condition and options to renovate the courts back to good playing condition.

The tennis courts have been a challenge for the past three to four years for the Recreation Committee. This year, we conducted an extensive Request for Proposals to determine options for restoring the courts. Seven different tennis court contractors visited our courts and offered their recommendations. All of our visitors found our courts in poor condition and beyond its lifespan. Their recommendations ranged from a complete rebuild (\$350,000) to a simple resurface (\$60,000) with no warranty. Costs have risen sharply post-Covid and added to the challenge.

The middle double courts (Courts 2 & 3) are original courts built in the 1960's. The upper single court (Court 1) and lower single court (Court 4) were built in the 1970's. However, records indicate the construction for the single courts were plagued with poor contractors and quality. The lower single court (Court 4) has suffered structural failure and settled more than 8-inches in one corner and therefore not financially repairable now. Court 1 has developed some uneven settling and has severe cracking in its surface, adding cost to its restoration. Court 2 and 3 are still level but the asphalt subbase is deteriorating due to age. Full replacement will be needed in the future as noted in the five-year reserve study.

The Recreation Committee has received bids from 4 contractors and thoughtfully reviewed their recommendations and costs. As well as restoring the racquet courts to good playing condition, the Recreation Committee would like to expand Pickleball access in Queens Lake. In both options, Court 1 would be restored and dedicated to Pickleball play with 4 courts available.

The Recreation Committee, with input from the BOD and Finance Committee, recommends the following proposal:

Restore Court 1 with another asphalt layer, new playing surface and add Pickleball color, posts and nets for 4 courts and resurface Courts 2 & 3 for tennis in a combined project this year. The projected cost is \$77,989 The current 2024 budget allowed \$ 37,000 for court restoration and conversion to Pickleball this year. An additional \$ 40,989 is needed to restore and resurface all three courts plus bring Pickleball to Queens Lake this year.

By combining repairs for all three courts this year, shareholders could realize a savings of \$ 10,841 in overall expense from spreading the project over two years. The additional funding for this option will be put to a vote of the membership of Queens Lake in an upcoming ballot question. The Recreations Committee asks you to vote YES on the upcoming ballot.


